BPEd and MPES Admission Rank list for the AY 2024-25

The Rank list of BPEd and MPES courses for the AY 2024-25 is subjected to the documents submitted by the applicants during credential verification and the admission test conducted and which is approved by the University of Kerala...

- Their admission is strictly provisional subject to the confirmation of the eligibility conditions prescribed by the University of Kerala and the College Prospectus for the AY 2024-25.
- Students should apply for Eligibility Certificate at University of Kerala before taking admission in the college.
- If any candidate fail to fulfill the eligibility criteria or in case certificates of any candidate in Rank list are found fake or forged and found physically and medically unfit, his/her admission will be summarily rejected at any point of time during the course.

DOCUMENTS TO BE SUBMITTED AT THE TIME OF ADMISSION

As the classes of BPEd and MPES commence from 25th July 2024, the candidates are required to seek admission on 20th and 22nd to 24th July 2024. The last date to complete the admission process is 30th July 2024.

Office will be functioning upto 5.00 pm on all admission days.

The candidates who seeking admission to the courses shall submit the following documents in original to the academic section of LNCPE at the time of admission. No additional time will be granted to the candidates for submitting the documents.

- a) Print out of completed online application.
- b) Eligibility Certificate from University of Kerala in case of candidates who have passed qualifying examination other than HSE/ VHSE conducted by Government of Kerala or the examination conducted by CBSE (AISSCE) and ISC and degree from University of Kerala (Not applicable for students who passed out from Board of Higher Secondary Examination, Govt. of Kerala and Degree from University of Kerala).
- c) Medical certificate issued by a cardiologist. (Form is available in the college website) (Produce copy, if already submitted).
- d) Medical Fitness certificate from the College Medical Officer
- e) Secondary School Examination (10th) certificate
- f) Certificate to prove Date of Birth (if not mentioned in the 10th certificate)
- g) Higher Secondary School Examination (+2) certificate and mark list (for BPEd candidates)
- h) Degree/Graduation certificate and consolidated/ all semester Mark sheet (for MPES candidates).
- i) TC from the Institution last attended.
- i) Course & Conduct Certificate.
- k) Migration Certificate from the Board/University last studied.

- Certificates from the village officer namely "The applicant belonging to Anthyodaya Anna Yojana (AAY) and Priority House Hold (PHH) category" or "The income or assets certificate for Economically Weaker Sections (EWSs) in General Category" for candidates under EWS
- m) Caste/Community Certificate for candidates under Scheduled Castes/ Scheduled Tribes quota.
- n) Non Creamy Layer Certificate in the case of SEBC candidates.
- The original fee receipt / transaction slip towards Registration fee
- p) Undertaking from the students & parents as per the provisions of anti-ragging verdict by the Hon"ble Supreme Court of India. (www.antiragging.in). Anti-ragging reference number to be submitted.
- q) Any other relevant certificate for any claim made in the application.
- r) Passport size photographs-2nos.
- s) Button file folder (transparent)-1
- t) The original fee receipt / transaction slip towards College Fee and Mess Fee. (Fee to be paid in the college accounts office only after submitting all the documents).

SPECIAL INSTRUCTIONS:

- 1. Failure to report for Admission: Candidates who do not obtain admission on or before 30th July 2024 will lose their eligibility. They will not be considered for any further regular allotment seats under any circumstance.
- 2. Any kind of false information provided by the candidate will lead to cancellation of admission.
- Rounding of marks / percentage to the nearest whole number will not be considered.
- 4. Any other item not specifically covered in this prospectus will be decided by the University and the decision shall be final.
- 5. Preventive measure against ragging: If an applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he/she had indulged in ragging, either he/she will not be admitted or shall be expelled from the educational institution.
