

#### BPEd and MPES Admission- Rank list for the AY 2025-26

The Rank list of BPEd and MPES programmes for the AY 2025-26 is approved based on the documents submitted by the candidates during credential verification and admission test result.

- Admission is strictly provisional subject to the confirmation of the eligibility conditions prescribed by the University of Kerala and the College Prospectus for the AY 2025-26.
- Students should apply for Eligibility Certificate at University of Kerala before taking admission to the programme.
- If any candidate fail to fulfill the eligibility criteria or in case certificates of any candidate
  in the Rank list are found fake or forged and found physically and medically unfit,
  his/her admission will be summarily rejected at any point of time during the
  programme.
- Admission dates: from 21<sup>st</sup> July to 26<sup>th</sup> July 2025 (Monday to Saturday).
- Last date for admission: 26<sup>th</sup> July 2025 till 12 pm.
- Reporting time:10.00 am to 1 pm on all days and till 12 pm on Saturday
- Place: Assembly Hall, SAI-LNCPE

#### DOCUMENTS TO BE SUBMITTED AT THE TIME OF ADMISSION

The candidates who seeking admission to the programmes shall submit the following documents in original at the time of admission. No additional time will be granted to the candidates for submitting the documents.

- a) Eligibility Certificate from the University of Kerala
  - **For BPEd candidates**: Applicable for candidates who have passed qualifying examination from HSE/ VHSE/Open School/Other State Boards.
  - (Not applicable for students who passed out from Board of Higher Secondary Examination, Govt. of Kerala and CBSE/ICSE)
  - **For MPES candidates**: Applicable for candidates who have passed qualifying examination (graduation) from other Universities except University of Kerala.

(Not applicable for students who passed out from the University of Kerala).

- b) Medical certificate issued by a cardiologist. (Form is available in the college website) (*Produce copy, if already submitted*).
- c) Secondary School Examination (10<sup>th</sup>) certificate
- d) Certificate to prove Date of Birth (if not mentioned in the 10<sup>th</sup> certificate)
- e) Higher Secondary School Examination (+2) certificate and mark list (applicable only for BPEd candidates)
- f) Degree/Graduation certificate and consolidated/all semester Mark sheet (applicable only for MPES candidates).
- g) TC from the Institution last attended.
- h) Latest Conduct Certificate.
- i) Migration Certificate from the Board/University last studied.

- j) For candidates under EWS category (only for Keralites): Original Certificates from the village officer namely "The applicant belonging to Anthyodaya Anna Yojana (AAY) and Priority House Hold (PHH) category" or "The income or assets certificate for Economically Weaker Sections (EWSs) in General Category"
- k) For candidates under SC/ST category (only for Keralites): Caste/Community Certificate for candidates under Scheduled Castes/ Scheduled Tribes quota.
- I) For candidates under SEBC category (only for Keralites): Non Creamy Layer Certificate and caste certificate
- m) The original fee receipt / transaction slip towards Registration fee (if not submitted)
- n) Undertaking from the students & parents as per the provisions of anti-ragging verdict by the Hon"ble Supreme Court of India. (www.antiragging.in). Anti-ragging reference number to be submitted.
- o) Passport size photographs-2nos.
- p) Button file folder (transparent)-1
- q) Medical Fitness certificate from the College Medical Officer

Fee to be paid on the same day after completion of the admission process.

### **SPECIAL INSTRUCTIONS:**

- 1. **Failure to report for Admission**: Candidates who do not obtain admission on or before 26<sup>th</sup> July 2025 (before noon) will lose their eligibility. They will not be considered for any further regular allotment seats under any circumstance.
- 2. Final decision regarding the eligibility for the admission to the programme will be subjected to the University of Kerala.
- 3. Any kind of false information provided by the candidate will lead to cancellation of admission.
- 4. Rounding of marks / percentage to the nearest whole number will not be considered.
- 5. Any other item not specifically covered in this prospectus will be decided by the University and the decision shall be final.
- 6. Preventive measure against ragging: If an applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he/she had indulged in ragging, either he/she will not be admitted or shall be expelled from the educational institution.
